

15 Description of Product

The equipment is a hand-held lighting torch, for use in Zone 0, temperature class T4, Gas group IIC protected by intrinsic safety ia. It is battery powered by three series connected primary 1.5Vdc AA alkaline cells housed within a main enclosure made from a yellow non-metallic material with a clear non-metallic lens. Inside there is an electronic PCB, a switch and a CREE XPE LED that provides the light output. The MSA XPS and 3325Z0 have the same shape, with the exception of a helmet mount pin on the MSA XPS.






PELI 3325Z0 (left)
